## PROJECT SPONSOR, LOCATION AND DESCRIPTION

The Agency received an application on March 14, 2024, and additional information on May 13, 2025, for a project proposed by Hamilton County, NY RSA2 Cellular Partnership d/b/a Verizon Wireless, and Hudson Valley Wireless in the Town of Arietta, Hamilton County, on or near New York State Route 8 in an area designated as Low Intensity Use on the Adirondack Park Land Use and Development Plan Map. The tax map number of the project site is: Section 127, Block 1, Parcel 1.110. The attached map shows the approximate location of the project site.

The project is briefly described as follows: The action involves installation of a 110-foot-tall monopine tower to support Hamilton County public safety radio antennas with installation of a 20-foot-tall receiver antenna at a mounting height of 110 feet above ground level (AGL) and installation of two 10-foot-tall transmitter antennas at a mounting height of 80 feet AGL. Also proposed is co-location by Verizon Wireless for installation of a three-sided panel antenna array located at a centerline mounting height of 100 feet AGL and co-location by Hudson Valley Wireless for installation of two internet antennas at a centerline mounting height of 75 feet AGL. Access to the site will be along an existing 1500±-foot-long logging road, which will be improved.
